
VI. URB members also deliberated on some points and recommended revision of the PhD Regulations to incorporate the below mentioned points :

- i. As per PhD regulation R12.1, the academic calendar of the PhD Programme is divided into two terms : **Term 1 : July to Dec and Term 2 : Jan to June** . DRC meetings should be held in a time bound manner at the end each term. The time frame for the conduct of DRC should be fixed as follows:-
 - **Term 1** : DRC meeting should be conducted between end of June to end of July.
 - **Term 2** : DRC meeting should be conducted between end of December and end of January
- ii. Examination Division may be requested to declare the results for the Ph.D Programme till mid June so that DRC of students for Final Registration can be conducted as per the time frame mentioned in pt.(i) .
- iii. A Ph.D student may be allowed to have only one supervisor and one joint supervisor at any time during her research.
- iv. The eligibility of Joint supervisor from outside IGDTUW was discussed in the light of improving the quality of research. The members suggested that a Jt. Supervisor from outside IGDTUW should have minimum 3 publications after completion of his/her Ph.D, out of which either atleast one publication should be in SCI indexed journal or 2 publications should be in SCOPUS indexed journals. Patents/ Book Chapters may be desirable. Guidelines for the eligibility of Jt. Supervisor from outside university in Applied Sciences & Humanities Department may be set after discussion at departmental level.
- v. A Joint Supervisor from outside IGDTUW shall submit the proforma form for Jt. Supervisor, his consent to be a Jt. Supervisor along with necessary documents for being approved as a Joint supervisor for a student.
- vi. For addition of a Jt. Supervisor, a student should give a write up to justify the role and contribution of the Jt. Supervisor leading to provision of facilities and value addition to her research work. The write up shall be duly recommended by both the supervisor and the proposed Jt. Supervisor.



- vii. Addition of joint supervisor should be permitted by DRC only upto one year after date of final registration of the student in the PhD Programme. However, this time frame for addition of Jt. Supervisor may be relaxed by the DRC in SPECIAL cases when supervisor goes on deputation / long leave due to any reasons / death / retires.
- viii. The slots for Joint Registration of a supervisor may be counted in accordance to the current UGC norms.
